

For households that have recently become “Residential-Tax-Exempt Households” or have been imposed with “Residential Tax Based Only on Per-Capita Rate” in the 2024 fiscal year

A Guide about Priority Support Benefits Due to Rising Prices of Commodities and Other Daily Necessities (¥100,000/household)

The City of Nagaoka has sent letters with the description of and application procedures for these benefits to the heads of households who are believed to be eligible.

● Regarding the Priority Support Benefits Due to Rising Prices of Commodities and Other Daily Necessities

In order to reduce the burden of the rising prices of commodities and other daily necessities, this national government benefit project will provide ¥100,000/household to applicable households.

- ① Households registered in the Basic Resident Registers of Nagaoka City as of June 3, 2024 (Reference Date)
- ② Households that were not eligible for the same benefits based on their residential taxation status in the 2023 fiscal year

Required Procedures for Receiving the Benefits

The “Confirmation Form” must be submitted, indicating the account to which benefits are to be paid and with photocopies of the required documents attached.

- After carefully examining the “Example Application Form,” fill in the “Confirmation Form” and attach photocopies of the required supporting documents.

The confirmation form must be completed correctly without any omissions.
(Note: If some items in the confirmation form are found to be false, you may be asked to return the benefit.)

- Return the completed “Confirmation Form” with the required supporting documents in [the return envelope via postal mail as soon as possible.](#)

Notice:

If your household meets the following conditions, your household might be eligible for Additional Child Benefits.

● Regarding the Priority Support Benefits Due to Rising Prices of Commodities and Other Necessities-“Additional Child Benefits”

- Households that are eligible for the Priority Support Benefits Due to Rising Prices of Commodities and Other Daily Necessities (¥100,000/household) and that have a dependent child aged 18 years or under (born on or after April 2, 2006) could also be eligible for “Additional Child Benefits” (¥50,000/child).
- Application procedures differ depending on the child’s date of birth. Consult the table below. Complete the procedures listed in the right-hand “Procedures” column for each child based on their status as listed in the left-hand “Child’s Situation” column.

If the household has a child who was born from June 4, 2024 to October 31, 2024	<ul style="list-style-type: none">▶ <u>If you are eligible, contact the call center below.</u>▶ <u>In order to receive the additional child benefits, a separate application form and photocopies of required supporting documents must be submitted by the deadline.</u> <p>Application Deadline: Friday, November 15, 2024 (must be postmarked no later than this date)</p>
Regarding children 18 years old or under (born on or after April 2, 2006) who are living in a dormitory or someone else’s home and not living in the same households as their legal guardians	<ul style="list-style-type: none">▶ <u>If you are eligible, contact the call center below.</u>▶ <u>In order to receive the additional child benefits, a separate application form and photocopies of required supporting documents must be submitted by the deadline.</u> <p>Application Deadline: Thursday, October 31, 2024 (must be postmarked no later than this date)</p>
